

# Ballot Rules

The following provides the Ballot Rules which will be provided as part of the New Zealand attendance ballot. The Ballot Rules will be advised to applicants during the ballot application process and will also be available on the Gallipoli 2015 website.

Two thousand attendance passes will be made available to the New Zealand public for attendance at the 2015 Anzac Day Centenary Commemoration at Gallipoli, Turkey, on 25 April 2015. Each person who is successful in the ballot (the pass-holder) will receive two attendance passes inclusive of their own. Details of the New Zealand ballot process can be found [here](#). An attendance pass provides confirmation to the pass-holder that they have been successful in the New Zealand Gallipoli Ballot to attend the Dawn Service at the Anzac Commemorative Site at Gallipoli, as well as the New Zealand memorial service at Chunuk Bair, Gallipoli, on 25 April 2015 (**the 2015 Anzac Day Commemoration**).

The attendance passes, which are free, will be allocated to each applicant who is successful in the ballot and to their nominated accompanying person.

These Ballot Rules are to apply to the attendance passes that are to be allocated through the ballot process:

1. An applicant must be a New Zealand citizen or a permanent resident of New Zealand and be 18 years or over as at 25 April 2015, to be eligible to apply for an attendance pass. There is no citizenship, residency, or age requirement for the accompanying guest nominated by a successful applicant.
2. Applications may only be made online or by post.
3. Only one application per person is permitted regardless of method of application. Duplicate applications are not permitted. Checks will be made to identify and exclude more than one application. If a person has also made an application in the Australian ballot for Australia's Anzac Day Centenary Commemoration in 2015, they may, without notice, be excluded from the New Zealand ballot.
4. Applications for the New Zealand ballot can be made as from 2359 hrs (NZDT) on 15 November 2013 until 2359 hrs (NZDT) on 31 January 2014. All online and postal applications must be received by the closing date being 2359 hrs (NZDT) on 31 January 2014. Online applications received after the closing date will not be considered. Postal applications received after the closing date will not be considered unless they are postmarked on or before 31 January 2014. If you apply online, by or at the end of the application process, you will receive an email confirming safe receipt of the application. If you apply by post you will not receive any confirmation of your application being received.
5. Each successful applicant for an attendance pass is able, but not required, to nominate an accompanying guest.
6. Successful applicants will be notified by email (if the application was made online) or by letter (if the application was made by post) within 60 days of the closing date for the ballot.

At that time successful applicants will be requested to reconfirm their details, and provide details of their nominated accompanying guest (if any). The successful applicant and the nominated guest will then be provided with their attendance passes in due course.

7. Unsuccessful applicants will not be notified unless they have elected to be placed on a waiting list. If successful applicants do not reconfirm their details when requested and by 2359 hours on 25 October 2014, and where applicable, do not provide the details of the accompanying guest by 2359 hours on 25 November 2014, their attendance passes (including the accompanying guest pass) will be forfeited and re-allocated.
8. Successful applicants and their accompanying guests are responsible for all their costs and expenses, as well as travel and accommodation arrangements, in relation to the 2015 Anzac Day Commemoration.
9. Attendance passes are strictly non-transferable and cannot be sold, traded, assigned, transferred, offered for sale or exchanged in any circumstances. The passes can only be used by the person whose name appears on the attendance pass. The pass-holder's passport number will be printed on the pass and checked prior to entering the 2015 Anzac Day Commemoration.
10. The New Zealand Government is responsible for conducting the ballot but does not accept any responsibility whatsoever for any technical failure or malfunction or any other problem which may result in any email or application not being properly recorded or received. No responsibility is accepted by the New Zealand Government for late or lost applications and proof of sending an application is not proof of receipt.
11. Applicants, who are successful in the ballot, and their nominated accompanying guests, must supply full personal and other details as required and must comply with all rules in relation to the ballot to be eligible for the attendance passes.
12. The New Zealand Government reserves the right at any time to cancel, change or postpone the 2015 Anzac Day Commemoration or the Ballot, if in its opinion deems it appropriate to do so. Should the Commemoration or the Ballot be cancelled, postponed or changed for any reason, the New Zealand Government will not be liable for any loss or expense incurred or to be incurred by any person, including but not limited to the cost or expenses incurred or to be incurred in relation to travel to the 2015 Anzac Day Commemoration in Turkey and/pr for accommodation in relation to the Commemoration.
13. The terms and conditions applicable to the attendance passes that will be provided to applicants and their accompanying guests can be found **here**. It should be noted that. Although the New Zealand Government is responsible for arranging the 2015 Anzac Day Commemoration in Turkey, together with the government of Australia, control over who

may enter Turkey to attend the Commemoration remains at all times with the Government of the Republic of Turkey. Therefore, an attendance pass does not confer on the person to whom the pass is provided with a right to attend the Commemoration.

# Ballot Terms and Conditions

## Introduction

Attendance passes will be provided free of charge by the New Zealand Government. An attendance pass provides confirmation to the person whose name appears on the pass (**the pass-holder**), that they have been successful in the New Zealand Gallipoli Ballot to attend the Dawn Service at the Anzac Commemorative Site at Gallipoli, Turkey as well as the New Zealand Memorial Service at Chunuk Bair, Gallipoli, Turkey, on 25 April 2015 (**the 2015 Anzac Day Commemoration**).

The purpose of the Commemoration is to commemorate, by attending the 2015 Anzac Day Commemoration, the sacrifice of all New Zealand men and women who have served in all wars, conflicts and peace operations by commemorating the centenary of the ANZAC Landings on the beaches of Gallipoli.

## Application of terms and conditions

An attendance pass is subject to these terms and conditions and the Ballot Rules as well as any instructions displayed at the Commemoration sites. These terms and conditions may be changed from time to time by the changes being posted on the Commemoration website ([www.gallipoli2015.govt.nz](http://www.gallipoli2015.govt.nz)) in the New Zealand Government's absolute discretion. The acceptance of the attendance pass, or its use at any time, by the pass-holder confirms the pass-holder's agreement to the following terms and conditions:

### Invitation to attend the 2015 Anzac Commemoration

1. The attendance pass provides confirmation to the pass-holder that they have been successful in the New Zealand Gallipoli Ballot to attend the 2015 Anzac Day Commemoration at Gallipoli, Turkey on 25 April 2015. Although the New Zealand Government will be responsible for managing the Commemoration at Gallipoli in Turkey together with the Government of Australia, ultimate responsibility for, and control of, the Commemoration remains with the Government of the Republic of Turkey. Consequently, the attendance pass does not confer on a pass-holder any right of access or entry to, or attendance at, the Commemoration.
2. The pass-holders agree that the provision to them of an attendance pass does not result in or create a contract between any pass-holder and the New Zealand Government or Ticketek Pty Ltd.
3. The New Zealand Government reserves the right at any time to postpone, change or cancel the 2015 Anzac Day Commemoration, if in its opinion it deems it appropriate to do so. The New Zealand Government also reserves the right to alter or change any aspect of the 2015 Anzac Day Commemoration without prior notification.

### Individuals are responsible for all travel and accommodation expenses and accept all risks

4. All attendance pass-holders are responsible for all costs, travel and accommodation and accept all risks whatsoever, in relation to the 2015 Anzac Day Commemoration, including risks associated with any cancellation or postponement of, or change to, the Commemoration.
5. The New Zealand Government shall not be liable for any loss, damage, cost or expense (including any damage to personal property) suffered, incurred or to be incurred by reason, or in respect, of the pass-holder's attendance, or proposed attendance, at the 2015 Anzac Day Commemoration. Under no circumstances will the New Zealand Government be liable for foreseeable or unforeseeable, or for direct or indirect, loss or damage in any form.
6. In particular, should the 2015 Anzac Day Commemoration be postponed, changed or cancelled, the New Zealand Government will not be liable for the payment of any compensation or for loss of money and/or expense incurred or to be incurred by the pass-holder.

### Cancellation of an attendance pass

7. (a) An attendance pass may be cancelled or revoked at any time by a delegate of the New Zealand Government without assigning a reason, and without giving the pass-holder any notice of an

intention to cancel or revoke the pass, if the delegate suspects that the pass-holder might breach or has breached any of the Ballot Rules, any of these terms and conditions or has acted or might act in a manner that is inconsistent with the purpose of the Commemoration or with maintaining its dignity, solemnity or safety .

(b) A delegate of the New Zealand Government may refuse anyone entry to the 2015 Anzac Commemoration in the delegate's absolute discretion and without prior notice, if the delegate suspects the pass-holder might engage in conduct that is prejudicial to, or inconsistent with, the purpose of the Commemoration or with maintaining its dignity solemnity or safety .

8. Any person who fails to comply with instructions from a delegate or other person purporting to act on behalf of the New Zealand Government at the Commemoration may be ejected. In addition, anyone found in the opinion of a delegate to be causing damage to any part of the site of the 2015 Anzac Day Commemoration, causing or threatening to cause harm to any other person at the Commemoration or in the near vicinity, or behaving in an illegal, anti social or aggressive manner, or appearing to be under the influence of drugs or alcohol or otherwise acting in breach of these terms and conditions will be ejected from the venue or the immediate vicinity without any reason being assigned for the ejection. The conduct leading to the ejection may also be reported to the local police.

#### **Particular things that are not permitted at the Commemoration**

9. The following articles are not permitted at the Commemoration: large flags, advertising or marketing messages, chairs, knives, fireworks, smoke canisters, air horns, flares, weapons, dangerous or hazardous items, laser devices, glass vessels, cans, poles, and any article that might be used as a weapon or compromise public safety. This list represents a non exhaustive list of the types of articles that are not permitted and the New Zealand Government retains a discretionary right throughout for a delegate to include additional items that are not permitted.

10. No alcohol is permitted to be taken into the Commemoration. Glass and cans are not permitted. No substances that are illegal under Turkish or New Zealand law will be permitted.

11. No professional photography equipment (eg zoom lenses, audio visual or cinematographic devices) will be permitted into the 2015 Anzac Commemoration without the prior written consent of the New Zealand Government or one of its delegates.

12. Smoking in enclosed spaces is prohibited. All signage instructions at the 2015 Anzac Day Commemoration must be observed.

13. No animals will be permitted, other than guide dogs for the blind and/or hearing dogs for the deaf and/or assistance dogs for disabled attendees.

14. The New Zealand Government by its delegate reserves the right to search all holders and their personal property and refuse admission to, or eject from, the 2015 Anzac Day Commemoration any person who refuses to be searched by a delegate, the police or any person acting on their behalf.

#### **Passes are not transferable and must be kept with the pass-holder**

15. Attendance passes are strictly non-transferable and cannot be sold, traded, assigned, transferred, offered for sale or exchanged in any circumstances. A breach or attempted breach of this condition is a ground for seizure or cancellation of the pass. Any pass obtained by a person in breach of this condition will result in that person being refused entry to, or participation in, the 2015 Anzac Day Commemoration.

16. Attendance passes cannot be used by anyone other than the person whose name appears on it. All attendance pass-holders will be required to have with them at all times photographic identification in the form of a passport or a current driving licence.

17. Any holder of an attendance pass must have a valid pass in their possession to enter the Commemoration sites and must retain their passes at all times during the Commemoration.

18. The New Zealand Government by its delegate may ask for reasonable proof that the bearer of the attendance pass is the pass-holder and has been provided with the pass in accordance with the Ballot Rules or any other ticket distribution methods employed by the New Zealand Government.

19. No re-admission to the 2015 Anzac Day Commemoration will be permitted.

#### **Filming of the Commemoration**

20. The 2015 Anzac Day Commemoration will be filmed for live and recorded transmission, including internet streaming. Attendance pass-holders hereby give their express consent to the use of their actual or simulated likeness in connection with the production, exhibition, advertising or exploitation of any film, video and/or audio recording of the Commemoration and/or any element thereof in any/all media throughout the world in perpetuity.

#### **Acknowledgement and application of terms and conditions, and defined terms**

21. In these terms and conditions, a reference to a delegate of the New Zealand Government is a reference to any person appointed by the Vice Chief of Defence Force, as his or her delegate for the purposes of the Ballot Rules, these Terms and Conditions or for the 2015 Anzac Day Commemoration.

22. The New Zealand Government has contracted with Ticketek to provide attendance passes to all persons successful in the New Zealand Gallipoli Ballot to attend the 2015 Anzac Day Commemoration. The attendance passes will therefore also be subject to Ticketek's terms and conditions.

23. The Privacy Policy, which can be found on the Gallipoli 2015 website ([www.gallipoli2015.govt.nz](http://www.gallipoli2015.govt.nz)), is applicable to all attendance pass-holders.

24. These terms and conditions are governed by the laws of New Zealand.
