In response to your request, the Ministry has provided two types of funding. The COVID-19 Vaccine Uptake Fund which has now ended, and the Ethnic Communities Development Fund (ECDF) which is active.

None of the above-mentioned groups were funded by the COVID-19 Vaccine Uptake Fund.
