Request for information

Thank you for your Official Information Act 1982 (OIA) request dated 22 May 2024. You wrote:

I am a student at the University of Otago and am working on a assignment on scams, specifically on elderly/older people who have issues with media literacy. Would it be possible to obtain data of scams on middle age and elderly people that have been committed in the past five years? Names are not needed, just statistics on age and number of cases per year.

There is no offence code for a scam. For the purposes of this request, I have chosen to provide you the information on the following offences:

- 4553 Obtain by Deception (Over \$1,000) Crimes Act 1961 Section 240
- 4554 Obtain by Deception (\$500-\$1,000) Crimes Act 1961 Section 240
- 4555 Obtain by Deception (Under \$500) Crimes Act 1961 Section 240
- 4556 Cause Loss by Deception (Over \$1,000) Crimes Act 1961 Section 240
- 4557 Cause Loss by Deception (\$500-\$1,000) Crimes Act 1961 Section 240
- 4558 Cause Loss by Deception (Under \$500) Crimes Act 1961 Section 240
- 4577 Acting as Medium with Intent to Deceive Summary Offences Act 1981 Section 16(1)(a)

The table below shows the number of such offences by calendar year, where the victim for each was 40 years or older at the time of the offence. This table shows the count of offences, not people. Each offence may have multiple victims and they could be of different age, so the sum of rows may be larger than the unique total of offences provided in the table.
