Tēnā koutou Ohakune Ratepayers and Residents' Society Inc

Thank you for your request dated 10 June 2024 to Kāinga Ora – Homes and Communities for information regarding the Teitei Drive, Ohakune development under the Official Information Act 1982 (the Act) as follows:

Please provide any communications (emails, texts, phone calls, meetings, or other), between RDC & KO since 28th Feb 2024.

These communications should include (but not limited to) 1.1/ Communications about OIA's that have been submitted to KO or RDC (regarding Barry Murphy, or the Ohakune Ratepayers and Residents' Society) 1.2./ Communications regarding Teitei Drive 1.3./ Communications regarding the funding or reimbursement of any monies

2./ In addition, please provide your policy regarding the sharing of personal information or OIA queries with parties outside of your organisation. Such query is regarding the sharing of information post the cancellation of the Teitei drive project. We believe questions being asked of either RDC or KO are being shared with either party where they should not be; the respective organisations should be answering the questions on their own merit without sharing such queries with others without prior consent. Please advise your policy and what has been occurring since 28th Feb 2024.

On 9 July 2024 Kāinga Ora extended the due date for response for 20 working days on the grounds of consultation. Following the notification of an extension to the due date for response on 9 July 2024, you emailed as follows:

"can you advise why 20 working days is required, how many documents by count for each type (email, document, memo) have been captured by this request?".

I can advise that Kāinga Ora did an email search for the period 28 February 2024 to 10 June 2024 which found 75 related emails and associate email trails. These emails were assessed to determine relevant information that is in scope of your request. The emails were then reviewed to establish whether the information could be released (in full or in part) or withheld/ refused under the Act. The source of the emails was mainly from Kāinga Ora and Ruapehu District Council.

Kāinga Ora has considered your request under the Act. Kāinga Ora has restricted this request to any *email communications* only between Ruapehu District Council and Kāinga Ora since 28 February 2024 to 10 June 2024 (date of request) and we refuse in part the aspect regarding *communications* (*texts, phone calls, meetings, or other*), under section 18(f) of the Act as the information requested cannot be made available without substantial collation or research.

In response to parts 1.1, 1.2 and 1.3 of your requests, Kāinga Ora has identified twenty-four email and associate email trails in scope of your request, as listed in the attached document schedule. Some information within these documents has been redacted as out of scope of your request or withheld under the following sections of the Act, as outlined in the document schedule:

9(2)(a) to protect the privacy of natural persons, including that of deceased natural persons.

9(2) (ba)(i) to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be

supplied.

9(2)(b)(ii) to protect information where the making available of the information would be

likely unreasonably to prejudice the commercial position of the person who

supplied or who is the subject of the information.

9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank

expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or

organisation in the course of their duty.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of information under section 9 is not outweighed by other considerations that render it desirable to make the information available in the public interest.

Repeated or duplicate emails have been removed and some of these are redacted within the documents. Emails or information already released to you in previous Official Information Act responses have also been removed from the documents being released to you today.

Regarding part 2 of your request, there is no policy on consultation therefore your request for this information is refused under section 18(e) of the Act as this information does not exist. We may consult before deciding on an official information request under section 15A (1) (b) of the Act.
