Tēnā koe Jas,

I refer to your information request dated 25 July 2024 made under the Official Information Act 1982 (the Act). You have requested the following information in relation to the 2024 Master of Teaching and Learning (MTchgLn) (Secondary Education) programme at the University of Otago:

- The number of applicants for the programme in 2024
- The number of offers made for the programme in 2024
- The number of acceptances of offers in 2024
- I would also like to request a breakdown of the applicants, offers, and acceptances by demographic information such as gender and ethnicity for each category.

Subject to the following comments, please see below the information you have requested.

- the data is correct as at 13 August 2024.
- the data includes all submitted applications. Applications that were started but not submitted are excluded.
- it is the University's standard practice to not report on information where it relates to fewer than five individuals and we consider that such disclosure could affect an individual's privacy and wellbeing. Where the numbers are very low, there is a risk that the identity of these individuals could be determined or inferred, and that their personal information could be revealed. Accordingly, where there are fewer than five individuals in a particular dataset, we have withheld the actual number. This is pursuant to section 9(2)(a) of the Act, in order to protect the privacy of natural persons.
