- While this would result in the demarcation of some parking areas, they would be making improvements to the parking infrastructure to enable efficient use of the space.

# Discussion points raised

Costs in these areas were rapidly increasing, sometimes over the rate of inflation, so imposing
fees was a means of keeping pace with that and enabling investment and providing a level of
