With regard to planning and abatement officers, please provide a notes column to provide their expertise in a specific work aspect if any (commercial, residential, urban, rural, etc.) and/or primary city suburb/similar they may work in.

There are no teams titled Planning or Abatement under Liam Hodgetts, and the Council has a number of teams that deal with different aspects of planning and enforcement.
