HEZBOLLAH ATTACKS ON ISRAEL s6(a)

Key Updates

Minister Wong has issued a statement on X on the Majdal Shams attack:

Australia unequivocally condemns the strike on the northern Israeli town of Majdal Shams. My thoughts are with those killed, those injured and their loved ones.

The leaders of Australia, Canada and New Zealand made clear on 26 July the grave concerns we hold about further escalation and destabilising actions in the Middle East.

We demanded Iran and its affiliated groups, including Hizballah, cease their attacks.

An immediate ceasefire in Gaza has never been more urgent, to protect civilians, see hostages released, and enable aid to flow.

The deaths and injuries in central Gaza overnight highlight the unacceptable human toll. We repeat our call on all parties to agree to a ceasefire.

The US has issued a statement through the National Security Council:

We condemn this horrific attack that reportedly killed a number of teenagers and children playing soccer on a Saturday evening in the village of Majdal Shams in northern Israel. Our hearts go out to the families of those who lost loved ones today, and we are praying for a speedy recovery for those who have been injured. Israel continues to face severe threats to its security, as the world saw today, and the United States will continue to support efforts to end these terrible attacks along the Blue Line, which must be a top priority. Our support for Israel's security is iron-clad and unwavering against all Iranian backed terrorist groups, including Lebanese Hezbollah.

The EU High Representative for Foreign Affairs, Josep Borrell, has made a statement on X:

Shocking images from the soccer field in the Druze town of Majdal Shams. I strongly condemn this bloodbath.

We need an independent international investigation into this unacceptable incident. We urge all parties to exercise utmost restraint and avoid further escalation.

Twelve children and youth have now been confirmed to have been killed by a rocket as in the town of Majdal Shams in the Israeli- occupied Golan Heights. Israel has attributed the attack to Hezbollah, which has denied involvement. heased under the s6(a)
