As far as I remember we developed a plan for permanent signage that can be folded out for the season and then folded when out of use. These have temporary speed reductions for the season and I think these have been installed. We're probably waiting for the Speed Management Plan to progress as that dictates the speed limit signage at what goes where and whether permanent or temporary. The sealion issue came up after we had consulted on the SMP so we couldn't include the Smails Beach section of Tomahawk Rd but there may be opportunity to include a permanent reduction in the SMP before it goes to council.

Speed humps didn't seem practical other than for the Smails Beach area and the need there depends on the outcome from the SMP and the seals were moving so its still a long stretch of road that would need multiple speed humps to have the desired effect. Closing the road except to residents would seem a more logical approach.

The first thing is we want to reduce speed limits in the area. We have consulted on the lower speed limits and held the hearings but the Speed Management Plan is on hold until the government releases it's plan for setting new speed limits, which is due end of March. In addition to the above permanent speed limit changes we have also had some temporary speed limits, roads closed and other temporary traffic control in place to try to protect the sea lions, Andrew Lord has been coordinating this with DOC.
