#### Report

1. At our request, we met with the US Embassy to register **our concern about the further US transfer of cluster munitions to Ukraine**<sup>1</sup>. As a State Party to the Convention on Cluster Munitions we said we were doing so in line with New Zealand's obligation to promote the Convention and the norms it establishes. Borrie noted New Zealand's humanitarian concerns about the post-conflict implications for Ukraine in view of the significant failure rates of Dual Purpose Improved Conventional Munition (DPICM) submunitions combined with the very large quantity that can be fired from ground-launched systems. There was no change in our position on Russia's illegal invasion of Ukraine.



Please see updated lines and background:

#### **Updated lines:**

- We acknowledge that the US (and Ukraine and Russia) are not parties to the Cluster Munitions Convention banning the use and transfer of these weapons. However, our position on cluster munitions is clear – New Zealand is a strong supporter of the Convention, and we oppose them. We will continue to make this clear.
- Even though Russia and Ukraine have not joined this Treaty, they must comply with general humanitarian law rules, including the prohibition on indiscriminate attacks. Any use of weapons including cluster munitions must be in accordance with these rules.

If asked about Ukraine's right to defend itself however it sees fit / whether alternative would be Ukraine not being able to conduct counter-offensive against Russia:

- We recognise Ukraine is facing an existential crisis through Russia's war of aggression, and we absolutely condemn Russia for the position Ukraine is in. But we are opposed to any use of cluster munitions in any circumstances, including any use in this conflict.
- Parties to an armed conflict including Ukraine and Russia in Russia's war of aggression –
  must comply with the laws of armed conflict at all time. This includes the prohibition on
  indiscriminate attacks. Any use of weapons including cluster munitions must be in
  accordance with these rules.

#### **Background:**

- Cluster munitions can be dropped from the air, or fired from ground-based systems like artillery or rockets, as in the systems going to Ukraine. Cluster munitions consist of containers that each disperse up to hundreds of small bombs across a wide area. Many of these bomblets fail to detonate, and lie in an unpredictable and dangerous state.
- Because of the indiscriminate nature of these weapons and widespread harm caused to civilians, including once a conflict has ended, the Convention on Cluster Munitions (CCM) was adopted in 2008. It prohibits all use, stockpiling, production and transfer of these weapons. The CCM entered into force in 2010, and has been signed by 123 states (and ratified by 111 States Parties, including New Zealand).
- Under the Convention on Cluster Munition's (CCM's) Lausanne Action Plan, states
  parties agreed to intensify efforts to promote the norms established by the CCM, to
  discourage "in every way possible" the use or transfer of cluster munitions, and to
  reinforce the growing stigma associated with these weapons to deter any future use.
- Although Russia and Ukraine have not joined the CCM (and are not bound by its
  provisions), as parties to an armed conflict they must comply with general humanitarian
  law rules, including the prohibition on indiscriminate attacks. Any use of weapons
  including cluster munitions must be in accordance with these rules.
- Officials raised with the US Embassy our concerns about possible US supply of these
  weapons when media reports first surfaced in January 2023, and again last week when
  reports suggested a decision by the US was imminent.
- There are reports of widespread cluster munitions use by Russia in Ukraine, and some instances of use by Ukrainian forces.
- According to the US Congressional Research Service, under US law the supply of cluster munitions with a detonation failure rate of more than 1% is prohibited. This can be waived by the President or Congress (as we understand was done in this situation, as the US claims the weapons have a failure rate of 2.35%).
- There have been significant discrepancies among failure rate estimates. Some manufacturers claim a bomblet failure rate of 2% to 5%, whereas mine clearance specialists have frequently reported failure rates of 10% to 30%. A number of factors influence reliability, including environmental conditions.

• The UK, Spain, Germany, Ireland and Cambodia have made public comments as states parties to the Convention. The German Foreign Minister reiterated Germany's opposition to cluster munitions; the Irish Taoiseach characterised the US decision as "the wrong decision"; and the Spanish Defence Minister emphasised that the "legitimate defence of Ukraine ... should not be carried out with cluster bombs."

Officials raised our concerns about possible US supply of cluster munitions to Ukraine with the US Embassy in January, and again earlier this month. Cluster munitions consist of containers that each disperse up to hundreds of small bombs across a wide area. Because of the indiscriminate nature of these weapons and widespread harm caused to civilians, the Convention on Cluster Munitions (CCM) was adopted in 2008, banning all use, stockpiling, production and transfer of these weapons. It is signed by 123 states (and ratified by 111 states, including New Zealand).

Under the CCM's Lausanne Action Plan, states parties agreed to intensify efforts to promote the norms established by the CCM, to discourage "in every way possible" the use or transfer of cluster munitions, and to reinforce the growing stigma associated with these weapons to deter any future use.

Under US law, supplying cluster munitions with a detonation failure rate of more than 1% is prohibited. This can be waived by the President or Congress (as we understand was done in this case, as the US claims the weapons have a failure rate of 2.35%). There are significant discrepancies among failure rate estimates. Some manufacturers claim a bomblet failure rate of 2% to 5%, whereas mine clearance specialists report failure rates of 10% to 30%.

# Supplementary 16

 Did the Minister raise the US' provision of cluster munitions to Ukraine with Secretary Blinken?

Yes. As we have done before.

New Zealand supports Ukraine in its defence against Russia's illegal war of aggression.

Russia and Ukraine, as parties to an armed conflict, must comply with international humanitarian law, and any use of cluster munitions must be in accordance with these rules.

Unlike New Zealand, neither Russia, Ukraine or the US are party to the Convention on Cluster Munitions. The Convention explicitly prohibits the use of cluster munitions, and our position on these inhumane weapons is clear. We are determined to put an end for all time to the suffering and casualties they cause, and are opposed to any developments that increase the likelihood of cluster munitions being used.

In fact, we have an obligation under Art 21 of the Convention to pursue universal adherence to it and to promote the norms the Convention establishes. We are also obliged to make best efforts to discourage states not party to the Convention from using cluster munitions. Our efforts to discourage the use of cluster munitions in the context of Russia's illegal invasion of Ukraine are consistent with this obligation, and so is our effort to discourage their transfer.
