Your Official Information Act request, reference: GOV-035304

Thank you for your request from the fyi.org.nz website, on 18 September 2024, asking for the following information under the Official Information Act 1982 (the Act):

- Has ACC contracted or purchased services from any of the following three companies at any time since 1 January 2024:
 - a. New Zealand Musculoskeletal Imaging Limited
 - b. NZ Cyclotron Limited
 - c. North MRI Limited
- If ACC has contracted or purchased services from any of these three companies please provide the
 dates on which those services were contracted for and the dates on which services were purchased,
 as the case may be

Of the three vendors listed above, ACC has only contracted services from North MRI Limited.

North MRI Limited's contract spans from 30 September 2022 until 31 July 2025. A search of NZ Cyclotron and New Zealand Musculoskeletal Imaging Limited returned nil results. The data is current to 30 September 2024.
