I refer to your request for information dated 20 September 2024 made under the Official Information Act 1982 (the Act). You have requested:

- "1. How many students were on conditional enrolment per year for the past 10 years, please provide this as a figure and as a percentage of the student body?
- 2. What percentage of students on conditional enrolment were removed from conditional enrolment?
- 3. What percentage of students on conditional enrolment were subsequently suspended from the University of Otago?"

Please see below our response to your request.

Due to the substantial amount of work that would be required to research and collate the information in the format you have requested, we are refusing your request under section 18(f) of the Act. In order to fulfil your request, our Student Management Value Stream Application support team would need to develop an extraction that would collate the data. They have advised that it would take them 15 hours to develop this complicated extraction, including testing to ensure that the information collated was correct. Such an undertaking is not practically possible, and would divert resources away from other important activities such as 2025 admissions, enrolments, and course approvals.

We have considered whether charging or extending the timeframe for responding to your request would help, as required by section 18A of the Act. We do not consider that either option would remove the impact that supplying the information would have on our operations.

While we cannot meet your exact request, we are able to provide some information that may be helpful to you. Firstly, we can provide information on the total number of students who were placed on conditional enrolment or suspended each year. Subject to the following comments, please see this information in the below table:

- Students who do not pass half of the points enrolled for in a year will be advised that they
  will be placed on conditional enrolment in the next year they enrol. In the next year in which
  they enrol, students placed on conditional enrolment will be required to enrol for a
  prescribed course of study.
- If fewer than half of the points enrolled for in the prescribed course of student across the full year of conditional enrolment are passed, the student will be suspended from the University for a period of two years.
- We note that all final grades for papers completed in semester 1 2020 were increased by 5 marks to account for disruptions created by COVID-19. In semester 2 2020, final grades of 47, 48 or 49 were bumped up to 50 (pass).

We are also able to provide a partial response to the more specific questions in your request. Since 2022, our Student Development Office has been coordinating engagement with all students on conditional enrolment in semester 1. Therefore, please see the below tables which show:

- The number of students placed on conditional enrolment for semester 1 since 2022 as a figure and as a percentage of the total student body;
- The number of students who were removed from conditional enrolment since 2022; and
- The number of students who were subsequently suspended from the University since 2022.

This information is subject to the following comments:

- Students who receive notification that they will be placed on conditional enrolment do not always enrol in the next subsequent year. They may take a year or two away from study, or never return to study.
- This data will not capture any students that enrolled for semester 2 study only, and there
  are a number of students on conditional enrolment who do this.
- 2024 data on students who were removed from conditional enrolment or subsequently suspended will not be confirmed until semester 2 results are confirmed in late November.
- We have provided percentage data for both the total student body and the student body to which the University's <u>Academic Progress Policy</u> (APP) applies. The Academic Progress Policy applies to all students studying from 100-level to 400-level, with the exception of specialised undergraduate Health Science programmes which have exclusion clauses in their own regulations. Please refer to this Policy for further information on the processes for managing and supporting student academic achievement.
