- Veracity of Israeli claims
- Other."

12 August 2024 – 2 September 2024	Email correspondence between the Defense Attaché in the Embassy of Israel in Canberra, the Ministry of Foreign Affairs and Trade's (MFAT) Export Control team and New Zealand Defence Force. The correspondence relates to an enquiry from the Defense Attaché on an export request from a New Zealand company, the name of which is withheld under section 9(2)(b)(ii) of the OIA: to avoid prejudice to the commercial position of another party. 2 May 2024	Senior MFAT officials engaged with their counterparts in the Ministry of Foreign Affairs of Israel and the Israel Defense Forces (IDF) about their international law obligations. Officials have raised specific concerns about the IDF's compliance with international humanitarian law and reports of Israeli strikes on United Nations (UN) and humanitarian facilities in Gaza.  Further details of this meeting are withheld under section 9(2)(h) of the OIA: to maintain legal professional privilege.

Where the information has been withheld under section 9 of the OIA, no public interest in releasing the information has been identified that would override the reasons for withholding it.
