- 9(2)(a) of the Act in order to protect the privacy of natural persons. The need to protect the privacy of these individuals outweighs any public interest in this information.
- 9(2)(f)(iv) of the Act as some information is under active consideration. The release of this information is likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served.

Where we have withheld information under section 9 of the Act, we have also considered any countervailing public interests in the release of this information. We do not believe that the public interests outweigh the need to withhold, in this instance.
