Circumstances of Death:

Background:

1. Suging Ji, aged 80, died while swimming in a pool at the Glenfield Leisure Centre on 10 August 2020. Mrs Ji was reported to have little in the way of medical history, and it was not clear whether her death was the result of drowning or whether she died because of a medical event. Because of this, her death was referred to the national duty coroner who accepted jurisdiction under the Coroners Act 2006. The duty coroner directed that a post-mortem be performed to identify the cause of Mrs Ji's death.

Post-mortem examination:

2. Forensic pathologist Dr Glenn competed a lesser post-mortem that consisted of a CT scan, toxicology testing and an external examination. Dr Glenn advises that Mrs Ji died of hemopericardium, or blood in the pericardial sac around the heart. This was caused by an ascending aortic dissection which is a tear in a large blood vessel in the heart. I accept Dr Glenn's advice regarding the cause of Mrs Ji's death.

Police enquiries:

3. The police, as is standard practice in a sudden death, made enquiries after Mrs Ji passed away. The police have confirmed, through the inquest officer, that there are no suspicious or untoward circumstances regarding her death.

Other matters:

- 4. Mrs Ji became unconscious while swimming in a public pool. Assistance was provided by a member of the public and by a pool attendant, who tried to resuscitate her while waiting for emergency services to arrive. Camera footage from the pool facility indicates that several minutes elapsed between the time that Mrs Ji first lost consciousness in the water and the time that resuscitation attempts were commenced
- 5. In determining the circumstances of Mrs Ji's death, I considered the time frame for her rescue from the pool. I sought further information from Dr Glenn on this issue. He has advised me that in Mrs Ji circumstances the timing would not have had any impact on the outcome and that she would not have survived even this had occurred more quickly.
- 6. I also sought further information from Auckland City Council, which is responsible for managing the Glenfield Leisure Centre. The Council has advised me that although the timeframe for identifying that Mrs Ji was in difficulty in the water was at the upper end of expectations, the response time and the steps subsequently taken were consistent with the approved policies, procedures and lifeguard training that were in place. An internal review of the events concluded that the procedures were adequately followed, and that the staff response was good. Some general opportunities for improvement and continuous development were identified and actions related to these are being implemented. I am satisfied with the steps that have been taken in this regard.

Decision:

- 7. I have reviewed the coronial and police files and have considered the information provided by the pathologist and Auckland City Council. I am satisfied that Mrs Ji died of natural causes, being hemopericardium resulting from an ascending aorta dissection. I am also satisfied that all the matters required to be established by me under section 57(2) of the Coroners Act 2006 have been established and the circumstances relating to Mrs Ji's death do not require an inquiry to be opened.
- 8. V extend my sincere condolences to Mrs Ji's family and friends.


