Tēnā koe

I refer to your request for information dated 19 November 2024 made under the Official Information Act 1982 (the Act). You requested:

"I am making an OIA request for the grade distributions of 100, 200, 300 level Bachelor of Oral Health papers for 2024 + 2023 DEOH201 (as this is missing in the 2023 grade distribution request)

This should specify how many students received each grade (A+, A, A-, etc) for each paper across 1st, 2nd and 3rd year, as well as the specific grade percentage of the highest mark for each paper."

I also note our email correspondence of 21 November and 29 November 2024, in which you clarified that you were also interested in receiving the grade distributions for the Bachelor of Oral Health (BOH) compulsory papers (MAOR102, SOCI101 and PUBH202), limited to just those students enrolled in the BOH programme.

We respond below to part of your request but need to extend the due date for responding to the remainder of your request.

Response for the grade distributions of the BOH papers:

We are pleased to advise that anonymised statistical academic results data for papers offered by the University will soon be published on our website: https://www.otago.ac.nz/about/quickstats. We are doing this so that all students can access this information at any time, without having to submit a request for information under the Act.

The published information will indicate the number of students who achieved a particular grade or percentage mark for Semester 1, Semester 2, Full Year, and Summer School papers for each year from 2019. This mark and grade distribution data will essentially be the same as that which we would provide in response to individual information requests made under the Act.

The University will continue to withhold information we necessary to avoid the identities of students being determined or inferred and their personal information being disclosed, to protect their privacy and wellbeing. Data will **not** be published:

- for any students in a paper, if fewer than ten (<10) students were enrolled in that paper; or
- for fail grade and mark data, if fewer than five (<5) students have failed a paper (i.e., a grade of Fail D, Fail E, Failed Compulsory Assessment or Failed Terms); or
- for students who withdrew from a paper or received an Aegrotat or Compensation Pass (where no final marks are awarded).

The first set of data will be published as it was held as at 31 December 2024. If the mark and grade distribution data for any papers was not confirmed at this date, data for those papers may not be initially published. Grade and mark distribution data will be updated later based on data as held at 31 March 2025 and again as held at 31 July 2025, to ensure the data becomes complete over time.

Accordingly, the University declines this part of your request under section 18(d) of the Act, as the information you have requested will soon be made publicly available. We will endeavour to contact you to advise when the data will be or has been published.

Extension for the grade distributions of the BOH compulsory papers (MAOR102, SOCI101, PUBH202):

The Act requires that we advise you of our decision on your request no later than 20 working days after the date your request was received. Unfortunately, it will not be possible for us to respond to your request in its entirety within the time limit. We are therefore writing to notify you, pursuant to section 15A of the Act, of an extension of the time to make our decision in respect of this part of your request, to Wednesday 29 January 2025.

This extension is necessary to allow for consultations necessary to make a decision on your request. We are currently working on our response to this part of your request, but as some of this information has only been confirmed very recently, we require some additional time to collate and complete our response. As the grade distribution data we will be publishing on our website relates to <u>total</u> paper enrolments, we need to provide the grade distribution data limited to BOH enrolments only separately.

We thank you for your patience – we will endeavour to provide our response sooner if possible. If you are not satisfied with our response and extension to your information request, section 28(3) of the Act provides you with the right to ask an Ombudsman to investigate and review this response. However, we would welcome the opportunity to discuss any concerns with you first.
