

# Briefing: Timelines and Announcements for New Charter Schools

#### Purpose of this report

The purpose of this report is to provide a comprehensive outline of the timeframes and announcements pertaining to the establishment of new charter schools. It aims to offer a clear and detailed schedule of key milestones, including the approval process, timelines, and anticipated opening dates.

Additionally, the report will highlight important announcements from relative authorities and stakeholders, ensuring that all parties involved are well informed about the progress and developments in the Charter school initiative.

#### The approval process

The approval process for charter schools in New Zealand involved several key steps and the collaboration of two main bodies, the Charter School Agency (CSA) and the Charter School Authorisation Board.

- Potential sponsors submitted applications to CSA detailing their intentions, educational approach, and a high-level business plan. The application had to demonstrate that the sponsor is a 'fit and proper person' as defined by the Education and Training Amendment Act, 2024.
- 2. The CSA reviewed the applications to ensure they meet the necessary criteria and were viable. This included evaluating the sponsor's capability and the proposed school's potential impact on the education system.
- 3. The independent Charter School Authorisation Board appointed following the passing of the Education and Training Amendment Act, 2024, evaluated the applications

recommended by the CSA. The Board considered factors such as the focus of the proposed school, the sponsors capability, and the level of community support.

- 4. The Authorisation Board made the final decision on which sponsors were approved to open a charter school. Successful sponsors will now negotiate contracts with the CSA, outlining learning performance targets, outcomes, and specific measures.
- 5. This structured process ensures that charter schools are established with a clear focus on improving student outcomes in maintaining accountability.

#### Background

- 6. The Charter School Authorisation Board has approved seven schools for CSA to enter contract negotiations. These schools have demonstrated their potential to deliver innovative and high-quality education to students, aligning with the overall goals of the Charter School initiative.
- 7. The CSA is currently undertaking detailed contract negotiations to finalise the terms and expectations for these new charter schools.
- 8. The Board has approved the CSA to support its consultation process with two state converting schools opening later in 2025, or the beginning of 2026.
- It is anticipated that two sponsors will sign their contracts with the CSA by the end of this week. The other sponsors are expected to follow suit in the coming weeks.

### Process for Establishment of Charter School

- 10. The CSA will provide comprehensive support, through Education Facilitators, to ensure that the schools are fully prepared to open. This includes guidance on critical operational aspects, resources, and funding. They will also help the sponsor navigate the regulatory requirements for opening.
- 11. The Minister will need to sign a Gazette Notice for the new schools that must be published. To reduce the timeframes, the Gazette Notice could be signed before the CSA finalises the contract with the sponsors. We will forward the Gazette Notices for the seven new schools early next week. They would then be published when the contracts are completed in line with announcements.

#### Announcements of Charter Schools

12. The CSA is working with your office on the announcement of the first Charter School establishment (proposed for Thursday 28 November). We will provide a draft Press Release for the Minister and a separate one for the Agency, with talking points to

accompany them. We will co-ordinate with your office regarding any media pitching. (Refer to Annex 1).

13. The CSA is also preparing communications to key stakeholders, including internal parties and unions.

#### **Profiles for the new Charter Schools**

- 14. The new charter schools are strategically located in Northland, the Auckland region and Christchurch, offering educational opportunities across both primary and secondary levels.
- 15. The schools are diverse in their focus and target different educational needs. They include schools dedicated to neurodiverse students, creative arts, Kaupapa Māori and second chance and disengaged learners. Details of the qualifications with Years 11-13 students will offer is included in the school profiles below.

16. The contract negotiation with each sponsor includes discussions about the percentage of registered teachers that will be employed at each school. In line with your

recommendation, CSA has negotiated within the set parameters that a minimum of 75% of teachers in each school are to be registered and have a current practicing certificate. Until positions are advertised and appointments made the exact percentage is not clear.

- 17. Schools with Years 3-10 students have three options available to undertake assessment of their students. These are: e-asTTle, PATs or Te Waharoa Ararau. We are yet to discuss these with sponsors but will work with them to determine the best option for their students.
- 18. Schools with Years 11-13 can offer NCEA, International Baccalaureate or French Baccalaureate as their base qualifications. It is expected that some schools with Years 9 -10 students will also be working towards these qualifications.

# Background

- The Charter School Agency is working to finalise contracts with the seven sponsors approved by the Authorisation Board to establish new charter schools.
- One school (Mastery Schools New Zealand Arapaki) has signed their contract, and the remaining schools are expected to sign within the next two weeks.
- The final part of the process of establishing a new charter school is publishing a gazette notice in the New Zealand Gazette.
- Draft notices for all seven approved schools are attached for your signature.
- The Charter School Agency intends to publish each of the notices separately after individual contracts are signed and announcements have been made.
