



Hi Mark

Thanks for your time on the phone today. I seek to urgently clarify a few points.

PTLs variation to schedule 3, 1, j in the concession to support summer operations of the lifts from 1 December - 31 May. Originally, the suggestion from DoC was that this was a "technical variation" and non-notified. amd PTL agreed with this assertion and sought to clarity as to how DoC wanted to receive the application. What we sought to understand is the specific format the department would like to see the concession variation take? Would you like a specific template form completed or a letter outlining the request or some other process to be followed to apply for the technical variation? We want to ensure that what you receive meets the department's definition of "technical variation" and the department's expectations.

Can you also clarify that you indeed require a cultural impact and environmental assessment (CIA, EIA) for a technical variation? It should be noted that we are not applying for a new concession and simply a variation to an already permitted activity. CIA and EIA seem overly excessive in this use case considering the concession has other mechanisms and controls built in to manage and evaluate effects.

I note the below sections where this proposed activity is inline with the intentions set out in the Tongariro National Park Management Plan;

- 1. **4.2.1 Special Areas and Management Zones,** The three amenities areas in the park are Turoa Ski Area, Whakapapa Ski Area/Iwikau Village, and Whakapapa Village. In these areas, there is a high level of infrastructure development and intense use. The level of impact and high level of associated use is anticipated in the National Parks Act 1980 by the provision for amenities areas. No mention is made around the specific time frame in which intended demand is anticipated, nor is there any reference to use in summer or winter specifically.
- 2. 4.2.4 Amenities Areas Objective; The effects of large-scale development and intensive use within Tongariro National Park should be confined to existing amenities areas which provide appropriate management to avoid or mitigate impacts. Provisions are already made for the summer lift activity to occur in the amenity areas to "avoid or mitigate impacts" to the rest of the park
- 3. 5.2 Ski Area Objectives and Policies > 5.2.1 Management of Existing Ski

Areas; 12 Ski areas may be utilised for summer activities without expanding the range of facilities provided for the principal winter use. There is provision within the park plan for the continued use of facilities otherwise utilised in Winter, i.e: lifts. The condition noted in the concession, schedule 3, 1, j contradicts the provisions in the park plan.

- 4. **5.2.15 Summer Use;** Public access to and use and enjoyment of Tongariro National Park may be improved if some ski area facilities, such as cafeterias and chairlifts, operate during the summer season. The park plan also notes policies inline with the intentions for the promotion of recreational values noted within the Conservation Act
 - a. The department will promote the summer use of ski area facilities insofar as they increase access to and enjoyment of the park by summer users.
 - b. The department will protect the ecology of the ski areas by marking suitable foot tracks.

It is clear, the use of existing facilities and infrastructure which would ordinarily be utilised for winter activities is permitted within the park plan provided there is not expansion of those facilities or services - which there is not.

It does seem that there has been a clear oversight and miss alignment of the principles of the park plan (and by extension the Conservation Act) in the preparation of the Pure Tūroa Concession. A technical variation to schedule 3, 1, j to permit year round use is the least that the department should undertake to rectify this matter. There should be no requirement for this to be a notified process, nor should this take the time DoC have proposed.

We have initiated the process to engage with iwi to secure their support for this variation. While iwi have been exceptionally busy recently, they recognize the significant importance of this matter to the local community, especially in light of the recent closure of the WPI Pulp Mill and Saw Mill. We anticipate their support will be both prompt and forthcoming.

I have included second is previous request around this information which he submitted to Anna over nine weeks ago for your reference.

Given the recent challenges faced by our region, it is absolutely PTL's intention to utilise the existing lift infrastructure for the summer 2024/2025 period to support the region and play our part in stimulating economic activity.



This is how the team believes would be the best way of progressing the variations that we have discussed:

a. Non-notifiable applications

- Aircraft (only one submitted processing can begin asap)
- Carpark boundaries not an application but can be corrected in the system as we process the aircraft variation. (Would need to be added by your team)

Timeframe: 4 to 6 months for non-notifiable applications.

b. Notifiable applications

- Anchor point above HNE outside ski area boundary (winter operations): already covered for winter season 2024 under Section 51A, will require a variation for 2025.
- Avalanche control outside ski area boundary (winter operations): already covered for winter season 2024 under Section 51A, will require a variation for 2025.
- Summer operations: not enough time to process for summer 2024/25, will require a variation for summer 2025/26.

<u>Timeframe:</u> Minimum 6 months for notifiable applications, to reach this timeframe a perfect application would be required (CIA and EIA) and iwi engagement underway.

c. Suggested that Winter Operations & Summer operations be treated as separate processes and CIA & EIA be provided for each of them separately. CIA sits with DOC, but we would encourage concessionaire to engage on their own to support their applications. d. All of the variations will require a minimum of six months or more (timeframes on DOC's website specifically say from 4 months to 20.5 months). Recommendation would be to submit the applications for next year's operations (both winter and summer) as soon as possible.

To do from here:

• **Pre-application hui.** The Community Team should meet with your team to do a pre-application hui for both Winter 2025 & Summer 2025/26 variations to get those applications in as soon as possible. This hopefully will ensure that a perfect application is received and ensure there are no unnecessary delays.



A bit of new context (as discussed with you (3(2)(a)). The shift from Management Stage A to B under VAL1 the week before last effectively suspended the authorisation under section 51A of the National Parks Act which allowed for the avalanche control work outside the ski area boundary. This means we must put a re-authorisation process in place which accounts for the necessary mitigation to work outside the ski area boundary and within the 1.5km exclusion zone. We're still trying to confirm the actual steps, but we need to map out procedures to manage the presence of the helicopter within the exclusion zone. I suggest you start an amendment or addition to your safety plan with the following recommended procedures.

- Contact with the GNS duty officer notifying them of your presence within the exclusion zone. This should include checking in and out.
- During the time spent within the exclusion zone, radio contact must be maintained with the helicopter.
- If the GNS duty officer communicates any volcanic activity (usually indicated by tremors), all activity must be immediately suspended, and the helicopter immediately moves out of the exclusion to a safe staging area which I suggest is the base area.

We will look to confirm more detail either later today or early tomorrow. If we put these procedures in place, we can then re-authorise the activity under section 51A of the National Parks Act noting the mitigation for volcanic activity.

Will keep you posted.

This document is to outline the operational processes in place during the increase or decrease in Mt Ruapehu's Volcanic Alert Level (VAL) on Tūroa Ski Field.

The VAL is altered by GNS when volcanic unrest activity changes (intensifies or lessons), these changes are communicated through Volcanic Activity Bulletins (VAB) released by GNS.

PTL follows instructions from Doc based on the scientific information they receive from GNS.

Pure Tūroa Limited acknowledges and understands what actions we must undertake during a change in VAL to protect all personnel.

Below are our operational changes in detail to reflect our response in VAL variations.

VAL 1 A escalating to VAL 1 B

At VAL1 B there is a 1.5km exclusion zone from the crater lake, this does not affect the operation of Tūroa, however it does change the protocols for avalanche control work above the HNE which requires entering the 1.5km zone. The below steps are put in place for avalanche control work thats requires the needs to enter the 1.5km exclusion zone these times.

- Contact with the GNS duty officer notifying them of your presence within the exclusion zone. This should include checking in and out.
- During the time spent within the exclusion zone, radio contact must be maintained with the helicopter.
- If the GNS duty officer communicates any volcanic activity (usually indicated by tremors), all activity must be immediately suspended, and all personnel must move out of the exclusion zone to a safe staging area.

Objective:

Complete helicopter deployment of avalanche control missions when required.

- Land helicopter at Giant Café staging area.
- Brief pilot on mission.
- Load machine one bombardier and one spotter (as per SAANZ Snowblasting SOPs)

VAL 1 escalating to VAL 2, 2km & 3km (Moderate to heightened volcanic unrest)

Upon a VAL variation PTL will await instruction from Doc as the grantor of the concession.

Once the VAL has been raised to VAL 2 stage C with a 2km hazard exclusion zone, this affects the operations of the High Noon Express (HNE) chair lift. At this VAL the HNE chair lift cannot be operated, the HNE will remain closed to the public. All guests and staff are to obey the 2 km exclusion zone. (Refer to map below)

If the VAL 2 stage C with a 2km exclusion zone is raised to VAL 2 stage C with 3 km exclusion, all lifts except the Parklane chair, Winter Garden Platter, Alpine Meadow Platter1 and the Sunkid carpet are not to operate, all guests and staff are to obey the 3 km exclusion zone. (Refer to map below)

De Escalation of VAL

De escalation of these restrictions can only occur once the VAL has been lowered by GNS.

Once VAL 1B has been reverted to VAL 1A all standard Turoa operations can continue, this includes the steps above for avalanche control via helicopter.






Figure 1 - DOC Volcanic Risk Management Zones







Thank you for the email from Sec 9(2)(a) on 10 July 2024 and from Cam on 11 September 2024 regarding the appropriate process to be able to use lifts all year round.

The District Office initially responded to this query on 15 July 2024 and advised we would consider this amongst other variations which we are currently in contact with you about. However, we confirmed summer use would likely need an Environmental Impact Assessment. Since this time, the Department has worked to understand the different variations you are proposing and the appropriate process for each of these.

We can now confirm that a variation to use the lifts all year round will require a full variation application, as it is not minor and technical in nature and will be likely to materially increase adverse effects. This application will follow the non-notified concession application process.

We understand that you would like to be able to undertake this activity for the upcoming summer season. For this to be possible, the following is required:

- PTL will need to undertake iwi consultation with all relevant iwi/hapū and get written feedback on this activity. The iwi and hapū entities you should contact are: Ngāti Rangi, Ngāti Hāua, Te Korowai o Wainuiārua, Patutokotoko and Ngā Tangata Tiaki. Please contact Cami Nieva, cnieva@doc.govt.nz if you would like any information about the appropriate contact details for any of these entities.
- The application will also need to include an Environmental Impact Assessment to explain how any adverse effects of the activity will be mitigated. This may be undertaken either by yourselves or contracted to a third party.

Without the above documentation, it will be unlikely that this variation will be able to be completed before the start of the summer season.

We apologise for not confirming the appropriate process and requirements until now.
