Response to your request

Part 2) of your request

As per our email to you dated 21 January 2025, the Department reviewed two boxes of physical documents relating to Rt Hon Dame Jacinda Ardern during her time as Prime Minister that cover the periods of those meetings you have identified in part 2 of your request. Upon completion of our review, we found no information within scope of your request. Therefore, we are refusing part 2) of your request under s 18(e) of the Act.

Part 4) of your request

In our email dated 31 January 2025, we proposed a refinement to part 4) of your request to ensure a search of electronic documents was more manageable. In your response dated 10 February 2025, you agreed to our proposed refinement. Therefore, we have decided to grant part 4) of your request. In order to respond to part 4) of your request, the Department will apply the following approach to searches for electronic documents:

Searches to be conducted for emails sent and received by Rt Hon Dame Jacinda Ardern's official email addresses and any information saved by the Prime Minister's Office.
