Date: 10 December 2024

Key issues

The term of the Chief Censor, Caroline Flora, expires on 19 July 2025. There is no provision in the Films, Videos, and Publications Classification Act for the Chief Censor to continue in the role once the term expires, unless reappointed by the Minister.

The Chief Censor appointment is one of the most significant statutory appointments in your portfolio. To source candidates with the necessary background and psychological resilience, the process has required executive search advertising, a rigorous interview process, and stringent psychometric and aptitude testing.

Ms Flora is performing very well in the role. She has managed the Office of Film and Literature Classification (the Office) with prudence and an appropriate public profile, while also ensuring financial sustainability and has enabled the Office to meet its statutory obligations amid rapid changes in the way content is accessed and consumed.

An early decision on whether you wish to reappoint Ms Flora is needed to follow sufficient time for a thorough search process if you decide not to reappoint and to seek new candidates.

The Department recommends that you reappoint Ms Flora as this would provide strategic and operational stability for the Classification Office. If you determine to seek new candidates, the Department will commence the process to appoint a new Chief Censor.

Purpose

- 1. The term of the Chief Censor expires on 19 July 2025.
- 2. This briefing seeks your agreement to either reappoint the current Chief Censor, Ms Caroline Flora, or commence a process to appoint a new Chief Censor. Your early indication is requested as the process for appointment for this position typically takes a substantial length of time.

The Chief Censor is a statutory officer established under the Films, Videos, and Publications Classification Act 1993 (the Act)

- 3. The Chief Censor is appointed by the Governor-General, on your recommendation, with the concurrence of the Minister of Justice and the Minister for Women. The appointment is for up to three years and the Chief Censor may be reappointed. Remuneration is set by the Remuneration Authority.
- 4. The Chief Censor holds office as chairperson of the Board of the Office of Film and Literature Classification (the Office). The Chief Censor is also the Chief Executive of the Office of Film and Literature Classification Office. The role has responsibility for allocating duties and responsibilities among staff, and ensuring the Office has sound strategic direction, financial performance, and operational conduct. The Chief Censor has additional functions under the Act, including granting the public leave to submit an unclassified publication for classification, allowing previously classified publications to be given a new classification, "calling in" unclassified publications to be classified, and granting exemptions upon request.
- 5. The Act has no provision for the Chief Censor to continue in the role once their term expires unless reappointed by the Minister. The Act also does not allow for an Acting Chief Censor. The Deputy Chief Censor would assume the Chief Censor's responsibilities if an appointment has not been completed by 19 July 2025.

The current Chief Censor may be reappointed and we recommend you do so

- 6. The current Chief Censor, Caroline Flora, was appointed 20 July 2022 for the standard three year term.
- 7. Ms Flora has degrees in science, psychology and law, and has held senior public sector leadership positions. Before her appointment as the Chief Censor, Ms Flora was the Associate Deputy Director General of System Strategy and Performance at the Ministry of Health. She has worked for most of her career in policy and service delivery in areas of preventing harm, including family violence and child protection. (We can provide more information on her professional background if you wish).
- 8. Ms Flora is highly skilled in operational leadership, which she demonstrated most recently in the restructure of the Office to ensure its operational and financial sustainability. She has built strong, productive, and collaborative relationships with sector leaders, and is well regarded in New Zealand and internationally. She has a well-developed understanding of the complexities involved in managing the balance of freedom of expression and harm prevention across the two primary functions of the office: making determinations on illegal objectionable material and tackling violent extremism online, and age and content classification of publications.

13. The Department recommends that you reappoint Ms Flora for a second three-year term as Chief Censor.

Next steps

- 14. If you agree to reappoint Ms Flora, a draft Cabinet paper for your feedback prior to Ministerial consultation in 2025 is attached as **Appendix A**. Once we have received your feedback on the paper we will provide an updated paper and all of the supporting documents required to complete the appointment.
- 15. If you decide to reappoint Ms Flora you will need to seek the concurrence of the Minister of Justice and the Minister for Women to the reappointment. Draft letters to the Ministers are attached as **Appendix B.**
- 16. The appointment would take effect from 20 July 2025.
- 17. If you wish to consider a new Chief Censor, the Department will commence the appointment process immediately, to ensure a decision is made before July 2025.

Proposal

1 This paper outlines my intention to recommend to the Governor-General that she appoint Caroline Flora as the Chief Censor of the Office of Film and Literature Classification (the Classification Office) for a second three-year term commencing on 20 July 2025 and expiring on 19 July 2028.

Background

- 2 The Classification Office is established under the Films, Videos, and Publications Classification Act 1993 (the Classification Act). Its role is to classify publications such as films, books or computer files which may need to be restricted or banned, and to provide information about classification decisions and the classification system.
- 3 The Classification Office is an independent Crown entity under the Crown Entities Act 2004 (the CEA), funded by a mix of Crown and third-party revenue.
- 4 The Chief Censor, together with the Deputy Chief Censor, has a range of duties, functions and powers under the Classification Act. Both the Chief Censor and Deputy Chief Censor roles are full-time positions as the Chief Executive and the Deputy Chief Executive of the Classification Office.
- 5 The Chief Censor and Deputy Chief Censor form the Board of the Classification Office. For the purposes of the CEA, the Chief Censor is the Chairperson of the Board.
- 6 In her role as the Chief Censor Ms Flora is the chief executive of the Classification Office and is responsible for allocating duties and responsibilities among staff.
- 7 The Chief Censor performs a number of additional functions under the Act, including the power to:
 - Grant members of the public leave to submit an unclassified publication for classification
 - Allow previously classified publications to be submitted in order to be given a new classification
 - 'Call in' an unclassified publication in order for it to be classified (this is usually the result of complaints from members of the public).

• Grant an exemption (upon request) from a classification restriction - for example a school teacher showing a restricted film to students

Process for appointing the Chief Censor

9 The Chief Censor is appointed by the Governor-General on the recommendation of the Minister of Internal Affairs, acting with the concurrence of the Minister for Women and the Minister of Justice, under section 80(1) of the Classification Act and section 28 of the CEA. Appointments are for up to three years and an individual can be reappointed.

Skills and experience needed by the Chief Censor

10 Section 80(3) of the Act states that when recommending appointments, I must have regard to a candidate's personal attributes, and also "*take into account... the person's knowledge of or experience in the different aspects of matters likely to come before the Classification Office.*" I have taken these matters into account when deciding to recommend Ms Flora's reappointment rather than running an appointment round.

Why reappoint the Chief Censor

- 11 The work of the Classification Office is complex and challenging involving as it does the balancing of freedom of expression and the prevention of harm for all New Zealanders.
- 12 Rapid changes in film, video, games and print production, distribution, and consumption brought about by technological developments further complicate this work and mean that it is important that people with the right mix of skills and experience are appointed to manage the Classification Office. I believe that from her work in, and prior to joining, the Classification Office Ms Flora has these skills.
- 13 My view is that Ms Flora has provided strong demonstration of the skills and leadership needed to succeed as Chief Censor in both the governance and management aspects of the role. Importantly, she has put the Classification Office in a more sustainable financial position despite falling revenues due to lower volumes of physical media being classified, and is well positioned to continue to manage cost pressures while still delivering on the statutory functions of the Classification Office.

- 14 I am also confident that she has a strong understanding of the inherent risks of censorship and the value of freedom of expression, and that the Classification Office's decision-making and public profile has not overstepped its mandate in her time in role. Ms Flora is also a skilled relationship manager who is respected domestically and internationally.
- 15 In summary I am of the view that a recruitment process (conducted within time and cost constraints to be completed by July 2025) would probably not deliver a better skill set than Ms Flora's. Ms Flora has the knowledge and skills needed to lead the Classification Office's implementation of key priorities and has the intellectual and conceptual strength to understand the complexity of its current and future challenges.
- 16 A Candidate CV Form is attached as **Appendix B.**

Representativeness of reappointment

17 I am satisfied that the reappointment of Ms Flora will provide for a wellbalanced Board in terms of gender, age, ethnicity and geographic representation, and an appropriate mix of skills and experience.

Remuneration

18 Under section 47(1)(b)(i) of the CEA, remuneration is set by the Remuneration Authority.

Appointment process and consultation

- 19 The appointments of the Chief and Deputy Chief Censor are made by the Governor-General on the recommendation of the responsible minister.
- 20 As required under the Classification Act, I have obtained the concurrence of the Minister of Justice and the Minister for Women. I have also consulted with Ministerial colleagues and have considered any feedback received.

Conflicts of interest

21 I can confirm that appropriate enquiries concerning conflicts of interest have been carried out, in accordance with the Public Service Commission appointment guidelines, to identify any conflict of interest that could reasonably be identified, and no conflicts of interest have been identified.

Communications

22 A press statement will be issued once the reappointment has been approved and Ms Flora has been notified.

Recommendation

23 It is recommended that the Committee note my intention to recommend the Governor-General appoint Ms Caroline Flora as the Chief Censor for a further three-year term of office commencing on 20 July 2025 and expiring on 19 July 2028.

Before her appointment as the Chief Censor she was the Associate Deputy Director General of System Strategy and Performance at the Ministry of Health. Ms Flora was previously the Group Manager, Principal Advisor, and Programme Manager at the Ministry of Health and New Zealand Police.

Ms Flora has worked for most of her career in policy and service delivery in areas of preventing harm, including family violence and child protection. She has led complex and sensitive policies, such as the End of Life Choice Act 2019.

In her first term in the role, Ms Flora has made substantial improvements to the way the Office operates, the quality of the Office's decisions, and the overall reputation of the Office. Importantly, she has the skills and strategic capability that will continue to be needed over the next period of appointment to manage cost pressures without disrupting delivery obligations. I have confidence that the Office is being managed to avoid the risk of over-reach into freedom of expression, and to maintain an appropriate public profile that reflects the status and constraints of the role of the Chief Censor.

For these reasons, I propose the reappointment of the current Chief Censor for a second term.

Talking points

Proposed appointment of Caroline Flora

- I propose to recommend to the Governor-General that she appoint Caroline Flora to the role of Chief Censor for a second three-year term of office to start on the date of appointment.
- Ms Flora has degrees in science, psychology and law and is legally qualified and has held senior, public sector leadership positions. Before her appointment as the Chief Censor she was the Associate Deputy Director General of System Strategy and Performance at the Ministry of Health. She has previously been the Group Manager, Principal Advisor, and Programme Manager at the Ministry of Health and New Zealand Police.
- Ms Flora She has worked for most of her career in policy and service delivery in areas of preventing harm, including family violence and child protection. She has led complex and sensitive policies, such as the End of Life Choice Act 2019.
- Ms Flora is highly skilled in operational leadership, which she demonstrated most recently in the areas of strategy, policy and operations in her work to restructure the Classification Office to ensure it operates within budget.
- Ms Flora enjoys people leadership, and her strength is in building and maintaining strong relationships.

The appointment process and remuneration

- When first appointed Ms Flora was selected as the recommended candidate via a public call for expressions of interest. She was interviewed by a panel of senior officials and has completed psychometric testing, including an assessment of her resilience. This is a critical consideration given the nature of the content seen by the Chief Censor.
- Remuneration for the Chief Censor is determined by Remuneration Authority.

The role of the Chief Censor

- The Chief Censor is a full-time role and has a range of duties, functions and powers under the Films, Videos and Publications Classification Act 1993, primarily in respect of what publications may be submitted for classification by the Classification Office, and under what conditions.
- The Chief Censor is Chief Executive of the Classification Office and, for the purposes of the Crown Entities Act 2004, they are also the Chair of the Board.
- I believe Ms Flora will continue to bring the necessary experience and skills to lead and manage the Classification Office and build and grow trusted relationships across the sector.
