### Official Information Act request: Move-on orders

Thank you for your email of 13 March 2026 to the Ministry of Justice (the Ministry), requesting information under the Official Information Act 1982 (the Act), regarding move-on orders. Specifically, you requested:

*I've already asked the Minister himself regarding the advice you have provided through to him through your ministerial briefings.*

*However I would like to ask you to provide the below outside briefings:*

*a) Instructions provided by any of the ministers to you (ministry) relating to move-on orders including requests for briefing.*

*b) Official requests / communique both to you and from you relating to move-on orders including emails requesting data, evidence and information etc.*

*To shine the light on how the minister is performing decision making & oversight on this matter on what matters both the ministry and minister considered on making their decisions affecting New Zealanders at large.*

On 2 April 2026, the Ministry of Justice (the Ministry) advised that the time frame to respond to your request was extended, in line with sections 15A(1)(a) and 15A(1)(b) of the Act, as the request was for a large quantity of official information and as consultations necessary to make a decision on your request were such that a response could not be made within the original time limit. You were advised that you could expect a response no later than 15 May 2026.

In response to your request, I refer you to **Table 1** below for a list of documents in scope and my decision on their release. Where practical, repeat emails and documents within an email chain have only been provided once, to reduce duplication. Out of scope information has been removed and some information has been withheld or refused under the following sections of the Act:

- section 9(2)(a) to protect the privacy of natural persons,

- section 9(2)(f)(iv) to maintain the constitutional conventions that protect confidentiality of advice tendered by Ministers and officials,
- section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions, and
- section 9(2)(h) to maintain legal professional privilege.

In withholding information under section 9 of the Act, I have considered the public interest and do not consider that it outweighs withholding the information at this time.

I am refusing some information related to your request under section 18(d) of the Act as the information is publicly available.
