Thank you for your email of 7 April 2026 to the Ministry of Business, Innovation and Employment (MBIE) requesting, under the Official Information Act 1982 (the Act), the following information:

Dear Ministry of Business, Innovation & Employment,

I noted, Energy Efficiency and Conservation Authority (EECA) - Member and Chair Applications close on 8 April 2026.

May I ask how you called for public nomination and on what platform you have call for public nominations e.g. govt.jobs website. A copy of your ad and pay rate for (member and chair) as well. Also, how many applications you have received for each of the role from the public and how many you have received from other nominating agencies such as TPK or Ministry of women etc for your role. How many you have shortlisted and how many you have interviewed. Further, How many vacancies are you looking to fill for this round for both role.

I understand that you may receive my request on the morning of 8 April 2026. Please only consider this request after it has been formally closed. I am unsure of the exact cut-off time for this application, but I understand that it closes on 8 April 2026.

How many you have shortlisted and how many you have interviewed.

The EECA chair salary is \$77,360 per annum and the board member salary is \$38,640 per annum.

Both roles were advertised publicly on Seek, Govt Jobs, LinkedIn and MBIE Jobs. There were 8 applications from the public for the Chair's role and 67 applications from the public for the members' roles. Both roles had 0 nominations from any nominating agencies. The process of shortlisting is currently ongoing.
