### OFFICIAL INFORMATION ACT REQUEST

I refer to your official information request of 3 December 2015 requesting the following;

“Patuharakeke Te Iwi Trust Board is seeking to advance a mahinga mataitai application and wish to consult with commercial fishers operating in our gazetted rohe moana. We need a list of operators and contact details.”

I understand that you have recently discussed your request with one of the Ministry's OIA advisers in relation to privacy concerns associated with the release of contact details of commercial fishers in a public forum such as the FYI website.

Following that discussion you have agreed that MPI would instead provide a list of the key industry organisations to you directly. These organisations are better placed to identify those within the industry who operate within Fisheries Management Area 1 (FMA1), which intersects the boundaries of your gazetted rohe moana, and who may be interested in talking with you about your mataitai reserve application.

Please find attached a list of the key industry organisations. Please note these organisations are publically available through an online search or a search through the yellow pages.

Included in the list are other industry organisations such as Aquaculture New Zealand, the New Zealand Recreational Fishing Council, and the New Zealand Sports Fishing Council that you may also wish to contact. These organisations have been included in the list as they have previously expressed to MPI an interest in being notified of new mataitai reserve applications that are being considered by MPI.
