Before we meet, can you have a good look at the current My School Entries and Results area available to learners via the NCEA login-in page - I'm assuming you have access to this through a friend or maybe you use your own.

Have a think about the type of learner data you require, both for now and in the future. For example, we hold data on NCEA, NCEA Endorsements, Course Endorsements, Literacy, Numeracy, Vocational Pathways, Scholarship and University Entrance. We run a number of rules engines that do the 'credit crunching' that determines if a learner has achieved a qualification or award. The standards themselves have a lot of related data, eg, version, type (internal/external and Achievement/Unit), payment status, exclusions etc etc.
