Dear Mr Stowers

Thank you for your email of 15 June 2016 to the Ministry of Education clarifying that you are seeking the following information:

- All information that the Ministry of Education has received from third parties about the [Aoga I Maota Charitable] Trust which includes any statements, claims, complaints, emails
- Any internal communications that the Ministry has had relating to the Trust including any information it has provided to the Minister from August 2015
- Any policy statements, directives or instructions from senior management regarding any instructions or directives to retrieve or withhold any funds allocated to Aoga I Maota Trust
- Information including emails, file notes, letters, phone calls and documents that the Ministry of Education has communicated with eternal people directly relating to Aoga I Maota or its associated organisations between June 2015 and the present date. Specifically we are requesting any information that has been exchanged between the Ministry and past employees of the Trust.

Further to our letter of 5 July 2016, extending the timeframe for our response, your request has now been considered under the Official Information Act 1982 (the Act).

I have identified 85 documents in scope of your request.

I am releasing 78 of these documents to you. Details of these documents are listed in **Appendix A.**

In compiling our response to your request, we have excluded administrative documents e.g. meeting requests, auto-replies, duplicates of documents, as well as any documents that the Trust has provided to the Ministry or which have already been made available to you. The excluded documents include:

- The suite of documents provided by Mo Tatou in response to the Ministry's audit report;
- The Targeted Assistance for Participation (TAP) Outcome Agreement and terms and conditions for the TAP3 grant;
- The EC8/08 applications submitted by Mo Tatou to change their licences from the Charitable Trust to individual limited liability companies; and

The RS7 Funding Return reports submitted by Mo Tatou.

We are happy to provide you with further copies of these documents upon request.

Similarly, we have not included attachments to K Base records which do not otherwise come within the scope of your request.

Where we have withheld information from the documents released to you, we have done so under section 27(1)(b) of the Act because the disclosure of the information would involve the unwarranted disclosure of the affairs of another person.

Seven documents in scope of your request are email exchanges for the purposes of giving or receiving legal advice. I am withholding these documents in full under section 27(1)(g) of the Act as disclosure of this information would breach legal professional privilege.

Under section 26(1) of the Act, you have the right to request we correct any information we have supplied to you where you believe the information to be inaccurate or incomplete and giving a misleading impression. You can do this by writing to the Wellington regional office at PO Box 30177, Lower Hutt 5040.

Thank you again for your email. You have the right to ask an Ombudsman to review this decision. You can do this by writing to info@ombudsman.parliament.nz or Office of the Ombudsman, PO Box 10152, Wellington 6143.
