Official Information Act Request Relating to the Prime Minister's Diary for 16 December 2015

I refer to your Official Information Act request to the Prime Minister of 25 August 2016 which asked: "*please release your itinerary and diary for the day of December 16, 2015.*"

Enclosed please find a copy of the Prime Minister's itinerary and diary for 16 December 2015. Some names and contact details have been withheld under the following sections of the Official Information Act:

- section 6(d) as the making available of that information would be likely "*to endanger the safety of any person.*"
- section 9(2)(a) as withholding the information is necessary "*to protect the privacy of natural persons, including that of deceased natural persons.*"

Where the information has been withheld, no public interest in releasing the withheld information has been identified that would be sufficient to override the reasons for withholding it.

It should be noted that the Official Information Act 1982 only applies to information held in the capacity as a Minister of the Crown.

You are entitled to ask the Ombudsman to review this response under section 28(3) of the Official Information Act.
