• The test certificate and display plan/worksheet for the Waikaraka Park Fireworks Display on 29 October 2016; and

• The test certificate and display plan/worksheet for Trusts Arena Spooks & Sparks 2016 Fireworks Display.

Please find enclosed copies of the outdoor pyrotechnic display test certificates issued for the displays. These have been printed directly from the Test Certificate Register. WorkSafe New Zealand does not hold signed copies of the test certificates. These will be held by the party to whom each display test certificate was issued.

You have also requested a copy of the display plan/worksheet for the displays. WorkSafe does not hold this information. Display plans/worksheets are prepared by the Approved Handler in Charge of the display and are then submitted to a test certifier for the purposes of obtaining a display test certificate. This information is not submitted to WorkSafe. I am therefore refusing your request for this information under section 18(g) of the Act as WorkSafe does not hold this information and I have no reason to believe it to be held by or more closely connected with the functions of another agency.
