Official Information Act 1982 request

Thank you for your Official Information Act (the Act) request of 1 January 2017, for information relating to child abuse and corruption. Questions one to five were transferred to Hon Anne Tolley, Minister of Social Development, as they relate to matters that fall within her portfolio responsibilities.

I am responding to questions six and seven (below), as they fall within my portfolio responsibilities as Minister of Justice.

- 6. Former Justice minister Judith Collins is on record as refusing to hold an official inquiry into conflict of interest allegations involving a supreme court judge, on the grounds that it would cause "incalculable damage to confidence in the judiciary." Your government has also refused to respond positively to information it holds on the lead-up to foreign trust legislation, despite allegations of systematic child abuse, including at high levels. What briefings or other communications, verbal or written, has your office had on high-level corruption?
- 7. What briefings or other communications, verbal or written, has your office or ministry had into the resignation of a New Zealand judge from the UK child abuse inquiry?

Question six

The table (attached at Appendix 1) lists the titles of the documents that fall within scope of your request. Only information within scope of your request has been provided. I have not interpreted your request to include provision of the documents themselves. Instead, I have interpreted your request to include only the titles of briefings or other communications received by my office since 8 October 2014, which is when I became Minister of Justice. I have further interpreted 'high-level corruption' as corruption in high levels of government.

In relation to your request for verbal communications on high-level corruption, I have consulted my records, which confirm that I have had only one meeting where this topic was discussed substantively. On 2 May 2016, I was briefed by Ministry of Justice officials on the London Anti-Corruption Summit (see Appendix 1 for relevant briefing and meeting agenda item).

Question seven

I do not hold any information relating to question seven and do not have any reason to believe this information would be held by another agency. Accordingly, your request under question seven is declined under section 18(g) of the Act.

You have the right under section 28(3) of the Act to complain to the Ombudsman about the decision relating to the information you requested.
