REQUEST FOR INFORMATION 2012/105

Greater Wellington Regional Council has transferred your request for information regarding all companies in the Creative HQ incubator to Grow Wellington Ltd, pursuant to section 12 of the Local Government Official Information and Meetings Act 1987, on the basis that this information is not held by Greater Wellington but is more likely to be held by Grow Wellington Limited (which is the 100% shareholder of Creative HQ Limited).

The requested information regarding the following three questions around Creative HQ incubator companies is attached as Appendix 1:

- *The calendar quarter when the company entered the creative HQ incubator*
- *Whether the company is still resident in the incubator, or if not its graduation date*
- *Whether the company is still trading*

However, under section 7 of the Local Government Official Information and Meetings Act 1987, we withhold the information around the following two questions on the basis that it is potentially commercial-in-confidence information which is not generally available to the public:

- *Whether the company has received any follow on funding, and if so, the resulting value of Creative HQ's shareholding*
- *The number of full time equivalent employees the company has*
