Thank you for your email of 13 April 2018 requesting the following under the Official Information Act 1982 (the Act):

How many square kilometres of conservation land (as defined by the Conservation Act 1987 and the Reserves Act 1977) is included in the proposed 2018 block offer?

Please split by conservation areas and scenic reserves.

Please also list the names of all the conservation land partly or entirely included in this block offer.

Your request included a link to a page on the New Zealand Petroleum and Minerals website, which provides information on the Block Offer 2018 Consultation Area. It is important to note that this is not the same as the final area for bidding. The Block Offer 2018 Release Area will be decided on and announced by the Minister of Energy and Resources following consultation with iwi and hapū.

The table below displays the square kilometres of conservation land in the Block Offer 2018 Consultation Area. A second table in Annex 1 contains the names of all conservation land that overlaps with the Block Offer 2018 Consultation Area. The latter also breaks down whether or not the Department of Conservation (DoC) considers each area Public Conservation Land (PCL).

Please be advised that the information above is based on current spatial datasets, which are not always 100 per cent accurate. The way these areas have been calculated is more accurate and consistent than standard geographic information system (GIS) methods, but tends to result in marginally smaller areas (typically less than 0.5% smaller).
