Our ref: SSC2018/0086

I refer to your email received 23 June 2018, where you have queried our response (dated 14 June 2018) to your earlier Official Information Act (OIA) request dated 5 June 2018.

In your request of 5 June 2018 you asked:

"I understand that you require recruitment candidates to for advisory roles to complete written exercises. Please provide a copy of all question papers used in 2017".

We interpreted your request to be for copies of "written exercises" that SSC **require** be undertaken for recruitment processes in 2017. Our response to you stated this information does not exist for the reason there is no such requirement for SSC recruitment processes.

Given your follow up question where you have asked for:

"The information on the discretionary written exercises used by managers in their recruitment processes on case-by-case basis"

We now understand you are seeking copies of any examples of written exercises that SSC has used in a recruitment process for any advisory role in 2017.

As we advised in our earlier response, this information is not required to be retained and is captured in individual write-ups on each applicant. However, we have consulted with the current managers of the business units within SSC and identified one example where a written exercise was used in a recruitment process in 2017.

A copy of this written exercise is enclosed with this response.
