OFFICIAL INFORMATION ACT 1982 : FILE 13/1

I refer to your request of 28 March 2013 where you sought information relating to the structure of the organisation, pursuant to the Official Information Act 1982.

- 1) ***The list of the titles of each unit, department, organisation, or other such division that exists inside the New Zealand Police.***
- 2) ***For each division, the number of FTE staff that have been assigned to each unit.***
- 3) ***The responsibilities of each division.***

In response to your questions, to clarify, the New Zealand Police is broken down by geographical regions in this order: district, area, location/station and department. It is also broken down into functions, by financial job codes. As you have mentioned, you are interested in units as organised by different function rather than regional breakdown, therefore, I have limited your request to job function.


The New Zealand Police financial job codes are broken down by title/responsibility and FTE as follows:
