Dear Mr Oldfield,

I refer to your request under the Official Information Act 1982 (the Act) received on 20 July 2018 requesting the following information:

Part One A breakdown of the number of persons deported to any of the Pacific Islands in the past 5 years (excluding US territories) following a conviction (whether or not that

person was also incarcerated in New Zealand).

Part Two A breakdown of the number of persons deported to any of the Pacific Islands in the past 5 years (excluding US territories) following the presence of 'new character information' (separate from those deported for criminal behaviour in New Zealand).

Part Three A breakdown of the number of persons deported to any of the Pacific Islands in the past 5 years (excluding US territories) following a conviction OR on the basis of 'new character information' that had a known link to gang activity at the time of deportation.

Our Response

Part One

In the past five years there have been 1040 individuals deported to Pacific Island nations. All data is based on the twelve month period from July to June for each respective year. Table One below provides the breakdown of deportation type in the past five years.

Tables Two and Three provide a further breakdown for each deportation type, destination country deported to the number of people each.

Please note that "Criminal" refers to all people convicted of a crime and people who have been brought to Immigration New Zealand's attention by the New Zealand Police for offending but charges have not been laid.

Part Two

It is not possible to provide a breakdown of the number of people deported to any of the Pacific Islands in the past 5 years (excluding US territories) following the presence of 'new character information' (separate from those deported for criminal behaviour in New Zealand). Therefore this part of your request is refused in reliance on section 18(f) of the Act as it would require substantial collation or research.

In accordance with section 18A I have considered whether charging or extending the due date for a response would assist with answering your request but it is my opinion that it would not.

Part Three

It is not possible to provide a breakdown of the number of people deported to any of the Pacific Islands in the past 5 years (excluding US territories) following a conviction OR on the basis of 'new character information' that had a known link to gang activity at the time of deportation. Therefore this part of your request is refused in reliance on section 18(f) of the Act as it would require substantial collation or research.

In accordance with section 18A I have considered whether charging or extending the due date for a response would assist with answering your request but it is my opinion that it would not.
