In answer to your questions:

- Yes, the easiest thing is to choose a canape package and a drinks package.
- I'm sure people would enjoy 1.5 hours if you are comfortable with that. It will be a good opportunity • for people to catch up and to network.
- Beverage package one is priced at \$32pp (1 hour) and \$37pp (1.5 hours).

Canapes:

- 1 hour @ \$24.50 (7 items) = \$4,287.50
- 1.5 hours @ \$26.50 (7 items) = \$4,637.50
- Additional add-ons are \$8.50 pp: (cheese; sushi; tasting plate; chocolate fondue). NB: I read it as . \$8.50pp for EACH of these additional items. So, I think 175pp x 8.5 x 4 = **\$5,950.** However, you might wish to elect only one or two of these add-ons.

Other queries:
