**Your Official Information Act 1982 request OIA1819-0431**

Thank you for your Official Information Act (the Act) request, which was received by the Department of Internal Affairs (Department) on 14 January 2019, and extended by 20 working days on 12 February, to allow more time for the completion of collation and consultations necessary to make a decision.

The Department provided its decision on your request on 14 March 2019. In our decision we advised you that one employee who had attended the training was on extended leave and that their correspondence could not be collated in their absence. We have now managed to collate the correspondence of this employee, which is included within the information we are releasing to you.

**The following documents are now being released to you in part:**

- 60 email chains from two DIA employees who attended the training.
- 12 Finance records related to the training, (excel breakdowns and invoices).
- 1 line from a document that references the training.

Some information has been withheld from these documents under the following provisions of the Act:

- Section 6(c) – to prevent prejudice to the maintenance of the law, including the prevention, detection and investigation of offences and the right to a fair trial.
- Section 9(2)(a) – to protect the privacy of individuals.
- Section 9(2)(b)(ii) – to prevent prejudice to the commercial position of the person who supplied the information, or who is the subject of the information.
- Section 9(2)(g)(i) – to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown, or members of an organisation or officers and employees of a department or organisation in the course of their duty.

I include in appendix a list of all documents, with annotations regarding what type of information is withheld

Please note that ZX Security course content, including PowerPoint slides and detailed agendas, has been withheld in full in accordance with section 6(c) and section 9(2)(b)(ii).

I consider that the withholding of information as mentioned above is not outweighed by other considerations which render it desirable, in the public interest, to make the information available.

You have the right to seek an investigation and review by the Ombudsman of this decision.
