Annex Relevant Extracts from Development Agreement

Development Objectives

- (a) The parties have entered into this Agreement to deliver the Development at pace and for the Development to form part of and contribute to the Housing Objectives.
- (b) The Crown enters into this Agreement in order that the Material Outcomes will be achieved and in the expectation that they will be achieved via the sale of the Land to the Developer and the Development.

Material Outcomes means an outcome that:

- (a) gives effect to the Housing Objectives; or
- (b) meets all the Milestones for the delivery of the Buildings; or
- (c) results in the purchase price payable by Eligible Purchasers for the KiwiBuild Units being no more than the applicable KiwiBuild Unit Price; or
- (d) achieves the Minimum Requirements;

Housing Objectives means, in respect of the Scheme of Development, the Crown's objectives in relation to relieving supply pressure in the housing market by:

- having new additional residential accommodation developed on Crown-owned land as soon as possible; and
- those developments including a proportion of KiwiBuild Units for on-sale to Eligible Purchasers; and

such developments contributing to meeting the Crown's housing objectives;

Milestone means each point identified as a milestone to be achieved by the relevant Milestone Date as set out in the Master Programme, each of which is more particularly set out in Appendix E (Milestones);

Milestone Date means the dates set out in Appendix E (Milestones) by which a particular Milestone must be achieved:

Minimum Requirements means the minimum requirements in respect of the Development set out in Appendix A (Minimum Requirements and Sale Prices) if, and as, modified under Part L (Modifications);
