This letter and attachments provide you with the third and final batch of documents in response to your request of 4 April 2019 under the Official Information Act 1982 (the Act).

I note that there has been a significant delay in providing this material to you and would like to apologise for this.

During this time important decisions have been made, including on the Climate Change Response (Zero Carbon) Amendment Bill and the New Zealand Emissions Trading Scheme review. As these matters are no longer under active consideration, I am able to release a more complete set of information in this final batch.

The documents released to you today cover the period from 1 October 2018 to 4 April 2019. These have been added to the data box previously set up for your request and are available via the hyperlink provided to you by email. Please do not hesitate to contact my office if you have any trouble accessing them.

Your original request sought the following information:

- 1.1 "Advice to the Minister for Climate Change and the Minister for the Environment on the range of options considered by the Government to address greenhouse gas emissions."
- 1.2 "Advice to the Minister for Climate Change and Minister for the Environment on how failure to address the adverse effects of climate change may specifically impact Māori and how measures to address climate change may specifically impact Māori."
- 1.3 "Engagement with Māori conducted by the Ministry and/or Minister on the Zero Carbon Bill and New Zealand Emissions Trading Scheme (NZ ETS) review consultation between April 2018 and March 2019, including engagement plans and hui minutes."

You also subsequently confirmed that you are seeking:

"formal advice which would have been presented to and/or considered by the Minister, contained in briefing papers (together with any supporting documents referenced in those briefing papers). [Your] request relates to information supplied to and/or considered by the Minister for Climate Change and the Minister for the Environment."

Application of the Act

There were 103 documents identified in scope of your request for the period 1 October 2018 to 4 April 2019 (i.e. the third batch of documents), as listed in the attached table. Please note, the document numbering in this table continues on from where the second batch of material ended.

Some information within these documents has been withheld under the following sections of the Act:

- 6(a) the making available of that information would be likely to prejudice the security or defence of New Zealand or the international relations of the Government of New Zealand
- 9(2)(a) to protect the privacy of natural persons, including that of deceased natural persons
- 9(2)(b)(ii) to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information
- 9(2)(ba)(i) to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied
- 9(2)(d) to avoid prejudice to the substantial economic interests of New Zealand
- 9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty
- 9(2)(h) to maintain legal professional privilege
- 9(2)(j) to enable a Minister of the Crown or any department or organisation holding the information to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations)
- information refused for the reason that the information requested is or will soon be publicly available.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

In some cases, such as the discussion regarding a Māori advisory group for climate change at the Ministry for the Environment (MfE), redactions have not been applied despite the fact that this work is still under active consideration and further decisions need to be made about

the best way for MfE (including the Climate Directorate) to realise MfE's Te Ao Māori strategy. In this case, the decision has been made that, on balance, the public interest is best served in releasing this information. Officials are in early discussions with Māori representatives to co-design a process that ensures Māori perspectives are represented in future climate change policy development and implementation across agencies. Draft Terms of Reference are currently being prepared and will seek feedback more widely from Māori and Crown agencies over the next few weeks.

Please also note that some out of scope information (e.g. project processes) has also been removed from the documents being released to you.

Two documents were omitted from the previous tranche released to you - *Hui minutes: Notes from hui on NZ ETS* (doc 109) and *ETS Forestry Package: Communications and Engagement Approach (joint MfE/MPI)* (doc 110). My officials have included them in this tranche of papers.
